This allows busy professionals to study for the CFA exam anywhere they go from their smartphone or tablet, whenever they have a few minutes.

IS CFA Prep Worth It?

Q: I am looking to take the CFA Level 1 in December. Has anyone used the Prep programs for additional help? If so, were they helpful.

A1: The curriculum is huge. if you stack the books CFA Institute sent you, it's about 8 inches tall. You stack the review books from a training institution, you would get about half of that. Its really just a time thing, more than anything else. The prep books extract the essentials for the examination. I personally didn't used prep books for L1 because I didn't have a job so time wasn't of the essence. But if you're busy, I'd say use a prep program though.

A2: So at my office there were a few of us taking Level I a few years ago. Our company only paid for the test/CFA materials, and I was cheap so I decided to use CFA materials only. A buddy in my group bought training program books, and I took a practice test from those a couple and found out that I was going to fail if I only used the CFA books. I bought a training program from Fitch and ended up passing. Followed the same strategy for Levels 2 and 3 and passed both on the first try.

The CFA books are actually pretty good on their own, but like any class you've taken it can be hard to tell from the textbook what will be on the test. I'd personally recommend Fitch Learning from my own experiences, but no matter what prep company you choose it helps to have someone show you what is going to be on the test, and this where I find Fitch learning very helpful.

CFA Level I Experience Tips

- **Don't ignore Ethics** As I did, thinking that its just those "do-the-right-thing" obvious questions that don't require much reading. I only discovered this in my practice exams period (1-2 months before exam date) and had to scramble to take it a little more seriously then.
- **Practice, practice, practice-** Given the multiple choice nature of this Level, the more questions you can attempt, the better, since it is clearer what is right and wrong to maximize learning. Best to allow at least 1 month prior to exams to focus on this bit as you will *always* discover new areas that you need more work on.
- Learn from history Always good to check out what are the common patterns in past exams. The free Level I commandments are pretty solid advice too.
- **Speed is key** Level I is about breadth and you need to be ruthless in time management (1.5 minute max per multiple-choice question), before you fall into this slippery slope and not be able to recover ground. Give yourself some time to mull over questions, but once times up, shoot and go!

- **Have a study buddy** It helped a lot in my experience and it is not just for academic reasons. It's nice to have someone to go for lunch with, moan about the dreaded pension accounting questions, or just to play foosball with during your break.
- Take care of yourself It's only the first battle out of three, so take care of your well being by achieving some balance between study, play and sleep. Drinking 3 coffee shots 5 nights in a row is NOT the way to go for this marathon! Incorporating some exercise, having enough sleep and more importantly eat well to concentrate better in those study sessions. It pays dividends in the long run.

So there you have it: my formula for Level I. It's no big secret and never will be, just some careful planning and disciplined hard work, interspersed with some fun. I hope you all found these useful.

CFA® exam preparation

How long does the CFA® Program take to complete?

With Level I exams in June and December and Level II and III exams in June, it is possible to complete the CFA program in two years. However, with a recommended study time of 300 hours per exam level, it takes most people three to four years to complete the full program.

Can Fitch Learning book the CFA® exam for me?

As a candidate you are responsible for booking the exam directly with CFA Institute. This is a simple process and only takes around 15 minutes to complete. We cannot book exams on your behalf. Your local institute may be able to help you book the exam. In Nigeria contact Huritt.

What are Fitch Learning's pass rates?

CFA Institute does not allow their prep providers to publish their pass rates. Our CFA exam preparation programs all follow the 'CFA Institute Prep Provider Guidelines' and we are so confident that you will find exam success with us that if you do not pass first time, we will refund your entire course fee. If I miss one of my classes can I attend one from a different program?

CFA® Examinations

The CFA® Program has three distinct levels, each culminating in examination, which must be taken in order before moving on to the next level. There are two exam sittings per year:

- December = Level I only
- June = all three levels

Each exam is 6 hours long and can be taken at exam centres all over the world.

Entry Requirements

Before you can apply for the CFA[®] Program, you must fulfil the following criteria set out by CFA Institute:

Meet the entrance requirements:

Have a bachelor's (or equivalent) degree

or be in the final year of your bachelor's degree program at the time of registration*

or have four years of professional work experience (does not have to be investment related)

or have a combination of professional work and college experience that totals at least four years. Part-time positions do not qualify, and the four-year total must be accrued prior to enrollment.

- Be sure you understand the Professional Conduct Statement and Candidate Responsibility Statement.
- Be prepared to take the exams in English.

 Have a valid international travel passport (required for exam registration and admission to the test center). Read the ID policy.

Booking your exam with CFA Institute

To book your exam you will need to register directly with CFA Institute. You must complete and sign a Professional Conduct and Candidate Responsibility Statement and pay an exam registration fee and an enrollment fee (first exam only).

Gaining the Charter

Having applied for and successfully completed all three levels of the exams, there are some other requirements to fulfil before gaining the charter:

- Have four years of acceptable work experience (gained before, during or after the exam phase)
- Join the CFA Institute as a member by:
 - 1. Submitting a professional conduct statement
 - 2. Providing current, completed sponsor forms
 - 3. Signing a certification form agreeing to comply with the terms of the Members' Agreement
 - 4. Exhibiting a "high degree of ethical and professional conduct"
 - 5. Apply for membership with a CFA Institute member society

Who books the exam?

You will need to book the exam yourself. For some companies we are authorised to book exams on your behalf, to find out if we do this for your company, please contact our client services team or your local institution.

Does the cost of the course include the exam fees?

The cost of the courses quoted on the website does not include the exam fee; this is payable directly to the examining body. Fitch Learning does offer a fully managed exam administration service for corporate clients, however individuals booking the course and exam on their own behalf are responsible for booking the exams themselves.

Studying online

How long do I have access to the portal?

You will have access to the online portal for as long as you require it. The syllabus may be updated periodically, but your portal will update with any changes.

How do I access the online content?

You will be sent joining instructions by email when you register for the course. This will also provide you with a link to your portal, your username and password.

Attending a classroom course

Is attendance registered?

Yes. If you are attending a classroom course, we will keep a track of your attendance. If you are coming to a class in our London training centre, you will be requested to sign in using our electronic registration screens outside the classroom.

What times do the courses run?

The Claritas Investment Certificate differs substantially from the CFA in a number of ways, including:

- □ **Program scope**: The CFA program is widely considered to be the investment profession's most rigorous credentialing program and the "gold standard" for investment management. The Claritas certificate is a foundation-level program that aims to impart an understanding of investment industry fundamentals. While the CFA curriculum is much more in-depth, the Claritas program can be a good way to "test the waters" for those considering enrollment in the CFA program.
- □ *Different target markets*: The Claritas certification is aimed at everyone in the investment industry who helps enable investment decision-making. The CFA program is targeted at those individuals who are directly involved in investment decision-making.
- □ Entry requirements: While the Claritas certificate is aimed at support staff in the financial services sector, there are no entry restrictions, and anyone can register for it. In contrast, the entry requirements for the CFA program are quite stringent the candidate should have a Bachelor's degree (or be in the final year of a Bachelor's degree program), or have four years of professional work experience, or have a combined four years of college and professional work experience. Candidates also have to sign a Professional Conduct Statement disclosing if they have been the subject of a written complaint or have been involved in any litigation or investigation for the previous two years.
- Certificate / charter requirements: Candidates who successfully pass the Claritas exam receive the Claritas Investment Certificate. To become a CFA charterholder, the candidate has to pass all three levels of the CFA program, each of which culminates in a six-hour exam. In addition, the candidate must also possess four years of qualified investment work experience of which at least 50% must be directly involved in making investment decisions.

		Passing levels : 82% of the 2,408 candidates who took part in the Claritas pilot program successfully passed the exam. The 10-year average pass rate (from 2003 to 2012) for all three levels of the CFA program was 42%; only one in five people who begins the CFA program successfully completes it and becomes a CFA charterholder.	
		Commitment levels: The Claritas program is cheaper and requires a far lower time commitment than the CFA. CFA candidates have to pay a one-time enrollment fee of US\$440, as well as an exam registration fee that can range between US\$620 and US\$1,170, depending on whether the registration is done before the first deadline in September or the final one in March. Each level of the CFA program takes about six months of preparation. While most candidates take between two and five years to	
		complete the program, successful candidates take an average of four years to do so.	
Who should enroll in the Claritas program?			
		Professionals working with investment decision makers in support or back-office / front-office functions – operations, administration, IT, human resources, marketing, sales, compliance, customer service.	
		Since there are no restrictions on entry into the program, the Claritas program may be a cost-effective alternative for someone looking to switch fields and get into the financial services industry.	
		It also appears well suited for students who wish to get into entry-level positions in financial services.	

The Bottom Line

The Claritas Investment Certificate is likely to find growing acceptance as the new foundation-level education and ethics standard for the financial service sector internationally. While most nations have country-specific credentials for industry personnel involved in areas such as operations and compliance – for example, the Series 99 and Series 14 exams in the U.S. – there are no alternatives at the international level. The fact that 3,300 candidates from 70 companies in 50 countries served as participants in the pilot program that was launched in January 2013 bodes well for its acceptance by large financial firms around the world. The Claritas Investment Certificate's association with the CFA Institute is also a powerful marketing tool, as 43% of the pilot study participants cited this as one of the top benefits of the program. The Claritas program may also possibly come to be regarded by potential CFA program participants as a useful sprint before embarking on the CFA marathon.
